Effective October 7th, 2016 on all right-of-way involved projects that have not been authorized for acquisition the following process will be followed. When right of way acquisition is authorized the road designer and road design supervisor need to be on the electronic distribution list. Upon the arrival of this authorization memo the road designer will produce plans and cross sections showing the authorized R/W lines in a pdf format and put them on DMS. When these files are complete they will reply to all on the right of way e-mail that these files are available for use.

These files will be named accordingly:

XXXXXXRDPREROW.pdf = Road plans with authorized R/W shown


XXXXXXRDPXSROW.pdf = Cross sections with authorized R/W shown.
