Bids on the following projects will be received by the Montana Department of Transportation, Construction Contracting Bureau, until 9:00 a.m. on APRIL 25, 2024. All bids will then be reviewed for correctness and then publicly read in the Department's assigned room.

Bid proposals, plans, cross-sections, dirt runs & erosion control plans, if available, and full instructions to bidders may be obtained from the Construction Contracting Bureau's website: <http://www.mdt.mt.gov/business/contracting> under the "Bid Package" link. Additional bid letting information is also available on this website.

Persons or firms desiring to qualify or bid on highway construction on the basis of a joint venture must declare their intention by executing a "Declaration of Joint Venture and Power of Attorney." Joint Venture affidavits must be included with the Bid Proposal.

Any contract entered into pursuant to this advertisement is subject to all appropriate state and federal civil rights laws. The prime and subcontractors are required to pay the wage rates set out in the bid proposal.

NOTICE TO BIDDERS

The following projects are funded in whole or in part by funds received from the Federal Highway Administration (FHWA), and their construction is wholly contingent on the state's continued receipt of those federal funds. If the federal funds are reduced or not received, the Department may choose to terminate any or all of the contracts for convenience under the provisions of Subsection 108.10. Any bidder on these projects, by submitting its bid or bids, understands and accepts the possibility of the contracts being terminated in the event federal funds are reduced or not available and by submitting any bid, each bidder waives any claims for costs or damages other than as specifically allowed by Subsection 108.10.2. In particular, bidders understand and accept that no payment will be allowed for any claimed anticipated profit for work not performed.

Project Lolo - Missoula will mill and overlay the asphalt in the existing travel lanes and select center turn lanes/medians. The remainder of the roadway that isn't milled and overlaid will receive a fog seal. Other work will include fog sealing of shared-use paths, joint sealing of all longitudinal pavement joints and transverse construction joints (with JOINTBOND®), high friction surface treatment to the horizontal curve at RP 86.1, new pavement markings, limited signing, electrical work, raised concrete median and concrete curb modifications (for left-turn lane adjustments in Lolo), and shoulder rumble strips. The project begins at RP 83.2 and extends approximately 7.6 miles north along U.S. Highway 93 (N-7), to RP 90.9.

This rehabilitation project on MT Hwy 37 in Lincoln County begins at the bridge over Sutton Creek, 3 miles north of Peck Gulch Campground (RP 48.6). The project extends 12.4 miles north to just past the intersection of (P-33) MT Hwy 37 and Salmon Drive in Rexford (RP 61.0). The work includes pulverizing the existing road surface and placing a new plant mix overlay surface with a chip seal. Additional work includes new signing and pavement markings, new guardrail, and rumble strips.
