

Jet service returns to West for first time since 1978

Commercial jet service made a triumphant return to Yellowstone Airport this week as the first commercial jet since 1978 touched down in West Yellowstone shortly after noon Monday.

The model CRJ200 Delta Airlines connection flight, operated by SkyWest, from Salt Lake City made its landing on the airport's western runway Monday as town officials, business leaders, and others looked on. The flight was welcomed with an archway of water from a pair of the airport's fire engines.

"This is a great day for West Yellowstone and for the state of Montana. For the first time since 1978, we can hear the whine of the engines of a commercial jet here in West Yellowstone," Director of the Montana Department of Transportation, Mike Tooley said. "This new option for travelers will provide a 30 percent increase in the potential number of seats on the flights into this airport."

Tooley went on to state that the return of jet service to West Yellowstone is just one of several new upgrades that the airport can look forward to.

"I would like to thank everyone here for their support. We want everyone to know that we are not going to ignore that support. Over the next few years, we intend to continue improving the facilities here," he said. "Over the next three years we are going to spend about \$7.2 million in state and federal funding to maintain the surfaces of the airport so that the jets can continue to come in."

Each of the new jet flights from Salt Lake City to West Yellowstone will be onboard the 50-seat Canadair Regional Jet (CRJ200). There will be two daily flights Thursday through Monday and one daily flight on Tuesday and Wednesday.

"The jets bring a new product to the West Yellowstone

community. A faster, more comfortable ride, and then seamless Delta connection access to the Delta network from Salt Lake City and worldwide," said Mike Ostler of SkyWest Airlines. "We are excited about a faster and more comfortable ride for everyone. We are excited to support you as a community."

The new jet service should also be a boost for the local economy. With the new jet service in place, the West Yellowstone Airport could see as many as 600 jet passengers arriving per week during this summer with an estimated total during the summer of nearly 10,000. The previously used turboprop aircraft could accommodate a maximum of 30 passengers per flight on 12 regularly scheduled flights, or 360 passengers per week and roughly 6,000 passengers per summer on average.

"Every time someone walks off that jet that mean money in the pockets of businesses and Main Street it also means we are marketing a part of our state that will bring guest from all over the world," Director of Montana's Department of Commerce, Meg O'Leary, said.

"Moving from the turbo-prop we will have faster more reliable service to the area and it will bring in more business to the community and more visitors to the park," said Airport Director Jeff Kadlec.

Administrator's Column

UAS Center of Excellence: Montana State University (MSU) has been selected as part of a team to operate a national Center of Excellence for Unmanned Aircraft Systems. Led by Mississippi State University, the team will focus on research, education and training in areas that are critical to safely and successfully integrating UAS into the nation's airspace. The team consists of 18 of the nation's leading UAS and aviation universities and a hundred leading industry, government partners. Doug Cairns, professor in MSU's Department of Mechanical and Industrial Engineering (http://www.coe.montana.edu/mie/) and head of MSU's UAS researchers said, "It has been a fierce competition, but we won. Now the work begins, U.S. Rep. Ryan Zinke (R-Mont.) initiated this effort over four years ago that evolved into a Mississippi State University and Montana State University team in 2012." With support from Montana Governor Steve Bullock's Office and the Montana Department of Transportation Director Mike Tooley, Congress was approached to develop a separate Center of Excellence for UAS in 2013. The team and topics have gone through many iterations to get to its present state. Between the Federal Aviation Administration needs, and the expertise of the team, it bears little resemblance to the initial activities. This ultimately blossomed into the final, successful ASSURE team to address the FAA needs for UAS technology. ASSURE, the name of the new team, refers to the "Alliance for System Safety of UAS through Research Excellence." Congress has charged the FAA with developing rules regulating commercial UAS. The new center will provide the agency and industry with research to maximize the potential of commercial unmanned systems with minimal changes to the current system regulating manned aircraft. MSU is a core member of the new center, and it will continue to conduct UAS research, but it is not a test site. MSU will receive funds for five to ten years for this center. The funds will require non -federal matching funds, including funds from the team's industrial partners. Congratulations to the ASSURE Team and MSU in its selection.

Flight Training for Veterans: The National Association of State Aviation Officials (NASAO) joined other general aviation associations and asked Congress to stop legislation that would limit funding for flight training for veterans. In the May 19 letter to leaders of the Veterans Affairs Committee, (http://download.aopa.org/ advocacy/150518FINAL LETTER HR 476.pdf) the groups asked Congress to stop the GI Bill Education Quality Enhancement Act of 2015. The legislation would cap annual benefits for veterans in collegiate flight training programs at \$20,980, not enough for them to earn a commercial pilot certificate and necessary ratings as part of a college degree program. The legislation was proposed after it was revealed that a small number of flight schools were charging veterans using their GI Bill benefits excessive fees for training. In the letter, it was suggested that better oversight and enforcement of existing Veterans Administration (VA) rules would have prevented the abuses. Instead of passing House Resolution 476, alternatives are recommended to: provide that the VA's enforce its own rules; treat all college degree programs at public institutions equally; encourage the use of flight simulator training when appropriate; enforce an approved FAA Training Course Outline: and advocate for a GAO study on the costs and requirements for veterans to obtain employable status as pilots.

Flight Training Scholarships: The Aircraft Owners and Pilots Association (AOPA) Foundation is currently offering scholarships for those who are learning to fly, and those who want to learn to fly. In total 25 scholarships will be awarded in amounts ranging from \$2,500 to \$12,000. The Flight Training Scholarships are available to flight students who are U.S. citizens or permanent residents, at least 16 years old and who hold a current Federal Aviation Administration (FAA) Student Pilot Certificate at the time of application. Students must also be AOPA members in good standing at both the time of application and when the scholarship is awarded, and must have not yet taken their FAA practical test/ checkride. The online application can be found at http://flighttraining.aopa.org/ ftscholarship.html. The application page includes FAQs and instructions for submitting two recommendations. The Application deadline is 10 p.m. (EDT), August 9, 2015. In addition, the AOPA Foundation's AV8RS program for teens ages 13-18, will offer \$15,000 in assistance for aviation education. AV8RS scholarships are available to any teen who is enrolled in the AV8RS program and who is pursuing an aviation-related goal, including a primary pilot's certificate (student must not have completed the FAA practical test/ checkride at time of application); study in an aviation/aerospace field through an accredited aviation program at a college, university, technical school or aviation academy, or attendance at an aviation or aerospace camp. A completed application and supporting documentation must be received on or before August 31, 2015. Historic Event to Take Place in Great Falls!

Montana is a state with a rich flying heritage. One of the most interesting chapters in our history is the Lend-Lease Program during World War II. The Lend-Lease was authorized by the Roosevelt administration to help the Russians combat the German invasion. Nearly all of Russia's fighter capacity was destroyed in the first several weeks of the conflict leaving ground troops, bases and cities unprotected from ferocious German bombing campaigns.

The Lend-Lease ultimately provided over 8,000 aircraft to the Russian military. The current Great Falls Airport was chosen as the ideal logistical location to congregate the US war planes before they were flown by the Army Air Corps 8th Ferry Group to Fairbanks, Alaska. Great Falls was chosen because of its frequent VFR conditions and it was out of range of an aircraft carrier based attack from the West Coast. From Fairbanks, aircraft were piloted along the Alaska-Siberia route in to Russian and ultimately the Russian front.

On July 17th through the 19th, Montanans will have perhaps the last opportunity to experience the historic migration. Three WWII AT-6 Texans and several other historic aircraft will arrive in Great Falls before setting out on the historic Alaska–Siberia Route. The public is invited to view these historic aircraft and hangars and attend events throughout the weekend. Fly-ins are encouraged. Construction of the Del Bonita Airport (Whetstone International) H28 started in 1982. It was dedicated in June of 1984. The airstrip lies directly on top, and parallel to the United States and Canadian border. The turf runway is 4440' long, 65' wide and at an altitude of 4336'. It is well-marked with white cones. There are tie down/ parking areas on both sides of the border for declaring customs. Amenities are sparse at Del Bonita, but the airport is a good location for crossing the border when flying North to Canada and Alaska. Remember to call customs 2 hours ahead of landing, and park on the side you will be travelling to.

Hands Across the Border sponsors an annual work session that is light on work and heavy on fun. Join us this year on July 11, 2015, for a chance to swap stories with our neighbors to the North, and to meet some of the friendliest border guards around. Planes start arriving around 10:00 am. Bring some gloves and walking shoes. All tools are provided. Maintenance includes weed eating, replacing runway cones, gopher hole filling and bait station filling.

After the work is done sit down and enjoy a BBQ/potluck lunch put on by the Canadian Flying Farmers with presentations by the Flying Farmers and US/Canadian Customs.
