2. Mechanisms to Receive and Channel Private Contributions to Wildlife Accommodation Projects (60 minutes)
 - a. Welcome J Mitch King, Executive Director Montana's Outdoor Legacy Foundation (MOLF)
 - o **Montana Outdoor Legacy Foundation (MOLF):**
 - **Can hold money as a trust manager, in endowed accounts, or in smaller restricted accounts, and have some fundraising and grant application capabilities**
 - **The needs that have been identified by the SC in terms of collecting and holding resources seem to align with how MOLF has been able to do this with other projects.**
 - **Very flexible with agreements and innovative in assisting to implement priorities**
 - **There are similar processes to look at in FWP, such as Montana WILD rehab center.**
 - **Idaho F&W Foundation that is similar has supported a wildlife structure with the state agencies. Mitch will follow up with Idaho contact.**
 - **MOLF has an overhead rate ranging from 5-10%**
 - o **A meeting for further discussion is scheduled for October 27th**
 - b. MWTP Project Program – *MOLF? Foundation? Account holding? Mechanism for Specific Projects?*
 - o **MDT Mechanism to Receive Funding:**
 - **MDT does not want to hold money until after the feasibility study is complete and a viable project is identified. Would want to draft a MOA between the different partners that outlines the resource commitments and how project will be implemented and maintained. Once the agreement is signed and funds have been transferred to MDT then design would begin and construction would follow**
 - **After completion of the feasibility study seems like the appropriate time to apply for potential federal grants. Ken noted that fundraising for a specific project is better than for a general fund.**
 - **MDT would bill the entity holding the resources. MDT overhead is 10-14%. MDT would provide a cost estimate prior to execution of MOA(s).**
 - **Once the project is finalized, MDT would return any surplus funds to the sponsor within a set period.**
 - o **Dwane drafted a funding process for review and discussion. To be further refined at follow up meeting**
 - c. MDT Projects (WA Process) – *MOLF? DK to work with Planning and Fiscal (ASO) to outline a more standardized process and produce a “white paper on how to”...*
 - o **MDT Projects (WAP) run through very similar process as outlined in the Draft MWTP Funding Process document. But rather than a feasibility study, the funding will be received prior to finalization of the environmental document/Scope of Work.**
