Section 402 Highway Safety Grant

Section 402

- Annual *Highway Safety Plan*
- Implements countermeasures that address behavioral related factors.
- Our most flexible source of funding.

- * Evaluate the efforts to make improvements
- * Improve the compatibility and interoperability of state and national data systems

Section 410 Alcohol Impaired Driving Incentive Grant

 - **Underage drinking prevention**
 - **Traffic Safety Resource Prosecutor**
 - **BAC testing of drivers involved in fatal crashes**

Impaired Driving Efforts

- Selective Traffic Enforcement (STEP)
- DUI Team (Montana Highway Patrol)
- Training for law enforcement
- DUI Court training and implementation
- DUI Task Force Facilitator

Impaired Driving Efforts

FFY 2012 Countermeasures (cont.):

- Traffic Safety Resource Prosecutor
- Contracted media campaigns
- Update DUI manuals for Prosecutors & Judges
- Alcohol screening, brief intervention, and referral to treatment (SBIRT) protocols

Funding for Traffic Safety Projects

The Montana State Highway Traffic Safety Office administers federal grant monies for safety programs aimed at reducing deaths, injuries, and property losses resulting from traffic crashes.

Some of these grants cover administration costs such as increased overtime patrols for law enforcement agencies and the cost to purchase new law enforcement equipment. Others cover the production and delivery of educational programs.
