#### **Older Driver Strategy 1**

Establish or designate a lead agency/ organization responsible for older drivers mobility and education.

## **OD-1** Overview/Purpose

**Overview** 

There is currently no designated agency in Montana that is responsible for managing policies and programs specific to older drivers.

#### Purpose

The purpose of this strategy is to pursue the designation of one agency with responsibility for programs and policies that support the safety and mobility of older drivers.

#### **OD-1** Activities

Efforts to identify a lead agency has been unsuccessful.

## **OD-1** Next Steps

The Emphasis Area team will continue to explore agency/organization interest in being the lead on this subject.

# Promote Safe Driving Practices for Older Drivers.

## **OD-2** Overview/Purpose

Overview

As people age their physical and cognitive abilities change, which can affect their ability to safely operate a motor vehicle.

Purpose

The purpose of this strategy is to educate and promote safe driving practices specific to older drivers.

## **OD-2** Activities

Aging Horizons & Community Pulse

- 30 minute TV program covering all major MT markets
- Discuss CarFit, benefits of program, logistics of CarFit events and appointments and Contact Information
- Discuss AARP Driver Safety Program, details of course specifics, times and locations

## **OD-2** Activities

**CarFit Events & Appointments** 

- August 2011 Event @ RMDC, Helena
- Private Appointments throughout year
- AAA and AARP CarFit Technicians trained across western and central MT
- Working on eastern region



# **OD-2** Next Steps

- Additional Media Coverage for safety/educational programs available
- Consider other venues and health fairs to promote safety and defensive driving courses
- Research insurance providers and their informational materials specific for older drivers

#### **Older Driver Strategy 3**

# Provide public information about transportation alternatives and mobility options.

## **OD-3** Overview/Purpose

#### Overview

There are many transit agencies and services throughout the State that offer an alternative means of mobility for older residents that choose to not drive.

New transit users, such as older drivers who recently have given up their keys, are not always aware of what services exist and how to use them.

# OD-3 Overview/Purpose Cont.

- 40 Transit Systems Statewide
  - 16 currently have websites with updated information.
- The remaining 24 agencies have a one page brochure on MDT's Public Transportation

#### Purpose

The purpose of this strategy is to work with transit agencies and other providers (car buddies, VA, etc.) to enhance the information and distribution about their services.

# **OD-3** Activities

- Brochures from individual agencies
- Websites with contact information and schedules
  - Currently hard to update
  - MDT working on mandating websites for all agencies
  - Non-internet users have family/friends who do use internet

# Encourage expansion and availability of transportation services.

# **OD-4** Overview/Purpose

#### Overview

Transit Services are often limited, especially in smaller communities across the State. To enable older drivers to make the choice to stop driving, they need to have alternative mobility options for transportation.

#### Purpose

The purpose of this strategy is to work with transit & other agencies across the State to encourage expansion and availability of services.

#### **OD-4** Activities

Research is available of other transportation options, i.e., senior companion and carpool programs.

MDT Transit is working with providers in developing rider programs within communities that pool their transportation resources.
