- Reduce the frequency of fatal and serious injury transportation incidents through coordination of efforts by:
 - Elected officials / Council
 - Public
 - Administrators
 - Educators
 - Enforcement
 - Engineers
 - Emergency Medical Responders
 - And others...

Benefits of Safety Planning

- Opportunity for coordinated efforts & shared resources within a community toward common goal
 - Common goals across multiple agencies
- Establish communication & form partnerships with Tribal, Local, State, and Federal officials
- Tool to leverage funding and resources
 - Enhanced efforts
 - SOAR and TTP Examples.
- Action Plan!

• Not focused on any one funding source or program

 - \$7,500 to update plan

 - All Tribes applied and received 2013 funds







Frequency of Fatality-related Motor Vehicle Crashes, by Year, Northern Cheyenne Reservation, 1996-2012







Frequency of Occupant Fatalities, by Year, Blackfeet Reservation, 1996-2012




Frequency of Fatality-related Motor Vehicle Crashes, by Single or Multiple Vehicles, Northern Cheyenne Reservation, 1996-2012




Frequency of Fatality-related Motor Vehicle Crashes, by Single or Multiple Vehicles, Blackfeet Reservation, 1996-2012




Frequency of Fatality-related Motor Vehicle Crashes, by Day of Week, Northern Cheyenne Reservation, 1996-2012




Frequency of Fatality-related Motor Vehicle Crashes, by Most Harmful Event, Northern Cheyenne Reservation, 1996-2012




Frequency of Motor Vehicle Crashes, by Top 10 Most Harmful Events, Blackfeet Reservation, 1996-2012




Frequency of Injury-related Motor Vehicle Crashes, by Top 10 Most Harmful Event, Blackfeet Reservation, 1996-2012




Frequency of Fatality-related Motor Vehicle Crashes, by Top 10 Most Harmful Event, Blackfeet Reservation, 1996-2012







Frequency of Fatality-related Motor Vehicle Crashes, by Driver Gender & Age Group, Blackfeet Reservation, 1996-2012
