#### **New Business-**

Kevin Dusko started the meeting with an overview of the Montana Statewide Impaired Driving Strategic Plan and the State's Response to the Impaired Driving Assessment Recommendations

States with a .60 or higher for the average alcohol -impaired driving fatality rate are classified as a high range state. Montana is at a .68 for 2019-2021 FARS data. Because the State of Montana has been classified as a High Range State for Alcohol- Impaired Driving fatalities additional requirements include an impaired driving work group, a statewide Impaired Driving Plan and an Executive Leadership Team that approves the Impaired Driving Plan.

The Impaired Driving Plan must follow NHTSAs Highway Safety Program guidelines on impaired driving and coincides with and is included in the state's strategic highway safety plan impaired driving emphasis area workplan states, also referenced as Montana's Comprehensive Highway Safety Plan Impaired Driving Emphasis Area.


Documents to be reviewed and approved by the ELT include-

## **Strategy Updates**

Strategy 1 - Deterrence and Enforcement

## **Strategy 2- Prevention and Education**

Sgt Ryan Janes of the Montana Highway Patrol reported in 2024 to date, MHP has trained over 120 law enforcement officers with agencies throughout the state. So far this year we have held one ARIDE course, one DRE course and 2 basic level SFST courses.

During the DRE course the 16 students were flown to Mesa, Arizona, where they conducted at least 12 evaluations on individuals who were under the influence of drugs, other than alcohol.

Five (5) more ARIDE classes have been scheduled and 3 additional SFST classes, one of which is for Malstrom Airforce Base. Multiple "wet labs" will be conducted during some of the SFST courses, where we dose individuals to an impairing alcohol concentration. During these wet labs, law enforcement officers get hands on experience with impaired individuals in a controlled environment, to strengthen their confidence and the validity of the NHTSA SFSTs. Additionally, two SFST refresher classes are scheduled so far, and we are also working with other agencies who need a SFST refresher course.

Dwight Nelson, Traffic Education Director, OPI shared that at last month's MTEA conference the group worked through a focus group exercise breaking into groups of 3-4 to review curriculum modules as a task of the driver manual curriculum update anticipated to be rolled out by next school year (2024-2025). Impaired driving and the risks of such behavior will be included in the update.

## **Strategy 3- Criminal Justice System**

Sgt Lacie Wickham reports the 24/7 Sobriety program continues and is currently working with Liberty County for twice a testing procedure, Choteau County on the SCRAM data system, and working with new coordinators, including tribal representatives, to stary up programs or restart those that have languished following COVID. Currently there are 23 active 24/7 programs across the state.

Ed Hirsch shared that he is working on the new prosecutor training that is scheduled to be conducted the first week of October. More information forth coming.

Judge Knisley reported that the STEER program, funded by NHTSA program, to date, has had 80 clients graduated. STEER court graduated 7 participants on 5/1/24. All participants had family and friends attend and each of the guests talked about how the participants life has changed for the better, and what the program has given back to them. CAMO also held a graduation on this date, graduating 6 participants. STEER will be holding a foundational training on July 15-19, 2024.

Bozeman launched a misdemeanor DUI Court on May 2, 2024.

#### Strategy 4 - Communication Program

New public education and awareness campaigns are being developed and will include speeding, motorcycle safety awareness, distraction among others.

## **Strategy 6- Program Evaluation and Data**

Currently reviewing the FFY 2024 program for 2025 and preparing the annual state's response on recommendations for ELT review and approval.
