

Relationship of Montana's CHSP with Agency Safety Plans & Programs








CHSP Purpose








Nevada's Safety Plan Purpose

To eliminate traffic-related fatalities and serious injuries by combining and sharing resources across disciplines and strategically targeting efforts to the areas of greatest need. Nevada has enlisted stakeholders from state, local, tribal, and federal agencies; institutions; private-sector organizations; and concerned citizens to develop goals and strategies to solve this problem.










Wyoming's Safety Plan Purpose

To steer the state of Wyoming "Towards Zero Deaths". All travelers in the state of Wyoming, whether they drive, ride, walk, or bike should safely arrive at their destination. The Wyoming plan strives to work towards this goal.







Arizona's Safety Plan Purpose

A statewide coordinated plan that provides a comprehensive framework for reducing fatalities and serious injuries on all public roads in Arizona. The Arizona plan has been developed by ADOT in cooperation with local, regional, state, federal, Tribal, non-profit, and private-sector safety stakeholders. The plan is a data-driven, multi-year plan that establishes a statewide vision and goal and identifies Emphasis Areas focused on reducing traffic fatalities and serious injuries.


















Fatal & Serious Injuries








Current Status



Reduce fatalities and serious injuries on Montana's roads by half, from 952 in 2018 to 476 in 2030 To met the 2030 Interim goal in the next five years requires an annual reduction of 73 fatal and serious injuries.






Zero by 2050



All Fatalities & Serious Injuries

To reach zero by 2050, based on the 2023 combined fatalities and serious injuries of 984,

would require an annual reduction of 36 per year.










- Oversight in development of Emphasis Areas (EA) and strategies








Agency Awareness of CHSP Safety Efforts






Agency Support of CHSP Safety Efforts






